#### **Detailed Rationale**

Infomerics Ratings has downgraded the ratings assigned to the bank facilities of MDA Mineral Dhatu (AP) Private Limited because of non-cooperation by the company despite repeated follow ups and lack of adequate information leading to information availability risk and hence uncertainty around its credit risk.

Infomerics Ratings assesses whether the information available about the company is commensurate with its rating and reviews the same as per its policy. The outlook is revised from stable to negative due to information availability risk.

The lenders, investors and other market participants are thus advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the company.

#### Non-cooperation by Issuer

Infomerics Ratings has been regularly following up with the company to provide the required data to monitor its assigned rating to the bank facilities, vide E-mail communications dated January 13, 2025, January 23, 2025, January 28, 2025, and concurrently over several phone calls. However, despite repeated requests by Infomerics Ratings, the company's management

has not submitted all the essential details required for detailed review of the assigned ratings. Availability of information is very critical in rating exercise.
